Advocacy Update

100+ DC Dentists Sign DCDS Letter Opposing Specialty License Proposal

There's Still Time to Add Your Name

DCDS is opposing a legislative proposal before the DC Council to require all specialist dentists to obtain a specialty license and be board certified in order to continue practicing in DC. DCDS estimates that approximately half of all specialist dentists overall would be ineligible to secure a specialty license because of the board certification requirement. This proposal is included in the <u>Dental Specialties Licensure and Scope of Practice Amendment Act of 2023 (B25-0632)</u>.

A hearing on the legislation is scheduled for Wednesday, July 10, starting at 9:30 AM. Testimony can be delivered in person or virtually over Zoom. It is important that DC dentists testify at the hearing to explain the devastating, long term impact this proposal would have on the number of dentists practicing in DC and consequently on the health and well-being of the public.

The legislation also include a provision to authorize dentists to administer FDA approved neurotoxins (e.g., BOTOX), but only for dental purposes. DCDS is advocating for a broader authorization to allow dentists with proper training to administer these substances for cosmetic as well as dental purposes.

DC Health Offers Funding to Support Oral Health

Senior Dental Services Program Funding Opportunity CHA-SDSP-5.3.24 Intended to support the efforts of DC-based dental practices to promote the dental health and welfare of the District's seniors, with an emphasis on engaging seniors in quality, comprehensive dental care.

Eligibility: For profit or nonprofit dental practices located and licensed to provide services within the District of Columbia, who are experienced in providing comprehensive dental services to seniors, currently billing to DC Medicaid, and have experience charging patients according to a formal sliding scale fee policy.

Additionally, we are advocating for:

- An increase in Medicaid fees for covered dental procedures.
- The ability of dentists to administer injections of FDA-approved neurotoxins (e.g., BOTOX) for cosmetic purposes.
- The appointment of actively practicing dentists to the Board of Dentistry. We are pleased to report that four DC dentists were recently nominated to seats on the Board, and we are working to establish a more collaborative relationship with the DC Board of Dentistry.

DCDS/ADA Dues Reduction

Thank You for Approving Pilot Programs Bylaws Amendment

DCDS Members Will See Greatly Reduced Dues Rates in 2025

DCDS members voted overwhelmingly to approve a proposed bylaws amendment that was the final action to enable participation in the ADA Membership and Engagement Pilot Program from 2025 through 2027. The pilot program is designed to test a new model for membership categories and dues rates with the goal of growing overall membership totals, particularly among early career dentists where there is a steep drop-off as dues are phased in. Most dues paying member dentists in DC will see their dues decline in 2025.

Under the amended bylaws, the board of directors is authorized to adjust membership categories and associated dues levels while participating in the pilot program. Historically, all changes to membership categories and dues rates required approval of the membership in a separate vote, which would have delayed and potentially blocked the ability of DCDS to fully participate in the pilot program.

In the final count, 91 members voted to support the amendment and two voted in opposition. The threshold to approve the amendment was participation by at least 58 members.

In Memoriam

It is with a heavy heart that we share news of the passing of Dr. Mohamed Zamaludin. Dr. Zamaludin was a longtime member of DCDS and a past president (1982-1983). The following text is reprinted with permission from his celebration of life held on May 3.

Mohamed 'Zam' Zamaludin D.D.S

October 17, 1938 - April 23, 2024

Dr. Mohamed 'Zam' Zamaludin was born to Mohamed and Jhyte in Guyana, South America (formerly British Guiana) on October 17, 1938. He went home to meet Jesus on April 23, 2024. Predeceased by his parents and 4 siblings, he is survived by his wife (Jemelia), daughter (Lisa), grandson, son-in-law, five siblings, and many beloved nieces and nephews.

Dr. Zamaludin was a long-time resident of the Washington, D.C., area. His life was the very embodiment of the American immigrant success story. He emigrated to the D.C. area in 1959 to attend Howard University, where he drove a cab to pay his way through both his undergraduate and graduate degrees. His fierce determination, persistence, and value of hard word ultimately resulted in him receiving many honors, including being elected President of the District of Columbia Dental Society, serving as Alternate Delegate to the American Dental Association, being inducted as a Fellow of the American College of Dentistry, Fellow of the Academy of General Dentistry, and Fellow of the International College of Dentistry.

Dr. Zamaludin believed in giving back to others, his community, and his profession. He and his wife were members of the Rockville Assembly of God and more recently Park Cities Baptist Church of Dallas. He also served as an Associate Professor at Howard University College of Dentistry. He treated special needs children in the D.C. school system and spent countless pro bono hours treating many others.

Dr. Zamaludin loved being a dentist, loved traveling with his family, and especially loved talking with others. He never lost his passion for the Guyanese Cricket team and would spend time explaining the rules of cricket to his football-playing grandson. After retiring in 2010, he and Jemelia moved to Texas to be closer to their daughter and their grandson. Without question, his grandson was the "apple of his eye." A blessing to others, Dr. Z, Papa, Dad, and husband will be sorely missed.

In lieu of flowers, the family prefers donations to Park Cities Baptist Church of Dallas or the American Cancer Society.

Do I Really Need That Insurance?

Assessing Your Practice's Need for Insurance Against Data Breaches and Cyber Crime by E. Andrew Gerner, R.K Tongue Co., Inc.

Warnings and reports of cyber-crime and data breaches are so frequent they become background noise. The purpose of this article isn't to establish the presence of a threat. <u>ADA publications</u> and actual breach events experienced by state dental associations, dental vendors, municipalities, and practices of all sizes around the country make awareness of the risk unavoidable. The true purpose of this article is to provide a toolkit and quick reference guide for assessing the risks and rewards of mitigating and transferring cyber crime and data breach exposure ...or not.

First, a word about risk management: work with a capable and sophisticated IT service provider to strengthen your IT security posture. Good IT managed service providers will ensure security patches are up to date, antivirus software is robust and current, and network policies like multi-factor authentication, remote access VPNs, partitioned remote backups, etc. are present and properly configured.

Next, educate yourself and staff about breach and cybercrime vectors like phishing, spear phishing, sitespoofing, device theft, and social media and online scams. Significant <u>free resources</u> are available through the U.S. Cybersecurity & Infrastructure Security Agency (CISA). If nothing else, periodic team meetings and reminders go a long way. Make sure staff verify that sender email addresses are authentic and do not click links or open files from unknown or suspicious senders.

No dental practice can realistically reduce the risk of data breach or cyber-crime victimization to zero.

No one knows for certain if and when you will experience a cybersecurity event and therefore *need* insurance for it, but you can choose today how painful the experience will be when you find out the answer. Here's how:

Option A:

A robust, standalone, data breach and cyber liability policy will cost a typical dental office several hundred or even a couple thousand dollars annually depending on the size of the practice and its existing cyber security controls. This solution will require an application and underwriting process that is difficult or impossible to complete without the assistance of your IT service provider. This is the solution for practice owners who want the least pain in the event of a cybersecurity incident. The policy will typically include:

- Reimbursement for lost collections revenue up to a stated limit
- Legal services for negotiating a ransom and/or interaction with regulatory authorities
- IT forensic services to identify source(s) and scope of the breach
- Public Relations and regulatory responsibility coaching

Assessing Your Practice's Need for Insurance Against Data Breaches and Cyber Crime

- Financial services for payment of a ransom (typically in cryptocurrency) if necessary
- Funds to pay for it all, up to a stated limit

Option B:

A cyber insurance endorsement on an existing liability or businessowner's policy. This is the solution for practice owners who are willing to endure moderate to severe pain in the event of a breach in exchange for saving a few hundred insurance premium dollars per year. Little standardization exists in the realm of this option except that coverage is generally very inexpensive and very limited. Obtaining a policy endorsement may require a light application and underwriting process. Most cyber insurance endorsements include a limited amount of funds to pay for some of the expenses associated with a cyber security event. Many companies that offer this type of endorsement may provide funds but *not* a panel of experts to support the needs of a cyber claim, e.g. negotiation, PR, IT, and financial services. With this option, you may receive reimbursement to pay for some required services, but it will likely fall short of the actual cost of those services. You will generally need to source and retain appropriate professional services on your own, and reimbursement for lost revenue collections are limited or specifically excluded. Lost collections could be more substantial considering the time required to DIY a cybersecurity event response.

Option C:

Nothing. The big benefit is no up-front cost or effort. The downside is five, six, or seven figures of potential loss and a complete lack of outside guidance or assistance should that loss materialize. This is the option for practice owners who are exceptionally lucky, like to gamble, and/or don't mind adversity or emotional and financial stress/distress. It goes by many names, e.g. "naked", "no parachute", "take my chances", "my IT company says I don't need it" (they didn't), "my CPA says I don't need it" (he or she wouldn't), or the author's personal favorite: "self-insuring" (definitely no segregated reserve funds, appraisal of risk, actuarial study, reinsurance, or stop-loss provisions found with true self-insurance programs. Just hoping it doesn't happen). Cheeky? Perhaps. Factually accurate? Yes.

In truth, most business and practice owners are just too busy to proactively research, select, and go through the process of obtaining many of the things they want or need, let alone cyber insurance that they don't really want but *may* need or only need *later*. A good broker with specialized programs can make it easier, even if it's still not effortless. <u>Contact your DC Dental Society endorsed R.K. Tongue broker</u>. Your future self will thank you.



HEALTH PROFESSIONAL LOAN REPAYMENT PROGRAM

On March 15, 2024, the District of Columbia Department of Health (DC Health) will accept applications for the Health Professional Loan Repayment Program (HPLRP). The program provides loan repayment services to eligible providers practicing in HPLRP-certified Service Obligation Sites (SOS) in the District.

Who Can Apply:

Primary Care, Mental Health, and Dental Providers, Including: Physicians, Dentists, Dental Hygienists, Registered Nurses, Midwives, Advanced Practice Nurses & Physician Assistants

The HPLRP will issue up to eleven (11) award contracts. Award contracts will cover two years of participation and award contract amounts will be equivalent to 44 percent of a provider's total eligible debt - up to a maximum of \$72,617.88 for physicians and up to \$39,938.83 for all other eligible primary care providers. The maximum award amount for four years of service is \$165,040.64 for medical doctors and dentists and \$90,770.07 for all other approved DC licensed providers.

Additional Information:

Providers interested in the program must be employed or have an employment contract with a certified Service Obligation Site (SOS) to provide direct patient care for at least 20 hours per week. A site must be an approved SOS for a provider to be eligible for the HPLRP. To become an SOS, a site must be a public or nonprofit entity located in a Health Professional Shortage or Medically Under-served Area/Population (HPSA/MUA/MUP) and must submit a Site Certification Application to the HPLRP. HPLRP applications, including recommendation letters and loan verification information, must be completed and received by DC Health by April 15, 2024.

Providers at for-profit facilities are newly eligible. See the website for details.

The anticipated contract start date for selected applicants is August 2024.
